PRIVACY AND COOKIE POLICY

- 1. This Cookie and Privacy Policy is applicable and enforceable for all persons ("Users") who use products and/or services of DEVLET CELIK GLOBAL TRADE ("Company") through our website named www.soaphistic.com ("Website").
- 2. This Cookie and Privacy Policy has been prepared by the Company in order to provide detailed information regarding the scope and purposes of the use of cookies on the Website by placing importance to the privacy and protection of personal data of the Users and to fulfill our obligation to inform regarding the use of cookies within the scope of the Law on the Protection of Personal Data ("Law"). Cookies are small identification and data storage files that are sent to your electronic devices when you access an online service through your browser and remember that your device has accessed the website or application. Cookies can send these files back to the source website or another website that recognizes cookies. In these files, information regarding your Web Site tour is stored in order to enable you to benefit from some of the basic features of the Web Site in order to remember your data when you use the Web Site again, and to use the Web Site more effectively and easily.

- 6. There are different types of cookies depending on the purpose of use and the duration of use. Our Company uses Mandatory Cookies, Authentication Cookies, Flash Cookies, Function Cookies, Analysis / Performance Cookies and Targeting / Advertising / Marketing Cookies.
- 7. Mandatory cookies and Analysis / Performance cookies cannot be disabled, but if you do not want other types of cookies to be stored on your computer, you can change your cookie usage preferences in the settings section of your browser or proceed without clicking the confirmation option on our Cookie warning screen. Cookie management settings vary from browser to browser, and detailed information about cookies is available under the help menus of modern browsers.
- 8. The Company may update, modify or repeal the terms of this Cookie Policy at any time. Any updated, amended or repealed provision shall apply to the user at the date of publication. Users' continuation of use of the Company's services or products following the change shall constitute his/her consent to the changes.

- 10. For what purpose personal data will be processed: Your personal data in the categories listed in Article 5 above is processed with purposes listed in Article 4.
- 11. To whom and for what purpose personal data processed by the company can be transferred: Your personal data are not transferred to any third party.
- 12. **Method and legal reason for collecting personal data**: Your personal data obtained through cookies are collected based on "explicit consent" as the legal reason.
- 13. Your rights under the Law regarding your personal data are as follows (a) Learning whether your personal data is being processed, (b) If your personal data has been processed, to request information regarding this, (c) Learning the purpose of processing your personal data and whether they are used appropriately for their purpose, (d) To know the third parties in the country or abroad to whom personal data are transferred (e) To request correction of your personal data in case of incomplete or incorrect processing, (f) To request the deletion or destruction of your personal data in case the reasons requiring the processing of your personal data disappear, (g) Request notification of the transactions made

pursuant to subparagraphs (e) and (f) to third parties to whom personal data have been transferred, (h) To object to the emergence of a result against the person himself by analyzing the processed data exclusively through automated systems, (i) To request the compensation of the damage in case of damage due to unlawful processing of personal data obtained through cookies.
